# 1. News from eseia

### Structural news

eseia Business Meetings, Governing Council and General Assembly Meetings, Brussels, 1-4 December 2015

Held back to back with the eseia Horizon2020 Update, the eseia Business Meetings successfully culminated with a series of important outcomes:

- The Proposal Analysis showed a high success rate for eseia receiving funding from EC. In the period 2014-2015, ten proposals had been submitted. As a result of the project acquisition efforts, BioEnergyTrain (BET), Phoenix and SuPREME were approved with a total funding of 6 Mio. € (as of 2. December 2015). Three other projects were still under evaluation. With a success rate of 20%, eseia was very successful on a European scale compared to the Europewide success rate of 14% for eligible full proposals under the first 100 H2020 calls.
- The eseia General Assembly voted the admission of TORBEL, Bio-C, University of Ljubljana, TH Köln, University College Cork and the Josef Stefan Institute as new eseia members. The year 2016 will start with 31 members from 14 EU countries.
- The eseia General Assembly adopted the eseia Accounts Q3 2015, and the eseia Work Programme and Budget 2016.



The next eseia Business Meetings would take place in Graz on 4 - 6 April 2016, back to back with the 2<sup>nd</sup> eseia- TU Graz Conference on Smart and Green Transition in Cities and Regions.

### The European Code of Conduct for EPC has been developed within the project Transparense



Damir Staničić, associate of the Centre for Energy Efficiency at the Jožef Stefan Institute, led very successfully the preparation of the European Code of Conduct for energy contracting in the context of the European project Transparense. The Code defines the fundamental values and principles which are crucial for the successful preparation and implementation of projects of energy performance contracting, and to contribute

to the development of the market for these services in order to support the European efforts to reduce energy use and greenhouse gas emissions. The Code has been very well received at European level, and now has 171 signatories, including the European Association of Energy Services Companies (eu.ESCO) and the European Federation of Intelligent energy efficiency services (EFIEES), and supported by the European Commission. <u>Read more</u>.

### Bioenergy 2020+ was nominated twice for the Lower Austria Innovations Award 2015

Two innovations from Bioenergy 2020+ were nominated for the Lower Austria Innovationsaward 2015. The first nomination is called the "Kerzenbrenner", which uses the long duration of combustion of briquettes and the steady combustion conditions, that maximize efficiency and create fewer emissions. The other nominated innovation is a heat pump system that combines a tiles stove with a heat pump.

## Phoenix

### Funding for H2020 MSCA-RISE Phoenix

As the European Commission has successfully signed the Grant Agreement of the Phoenix Project, the project officially started on the 1<sup>st</sup> of December 2015. This four-year international, interdisciplinary, cross-sectorial project is bringing together a total of 14 EU and 2 non-EU (Armenia and Belarus) countries in the field of non-conventional Bioresources.A kick-off meeting was held on the 4<sup>th</sup> of December in Brussels, were the mobility's between the involved partners were discussed. Secondments of a total of 62 (early stage and experienced) researchers from 15 countries for a total of 306 PM would be realised

### **Training activities 2016**

The ETP programme enables students, academics and professionals to take the next steps in climbing the stairwell to excellence and in ensuring participation of wider circles in the European Research Area in European programmes. The portfolio of the ETP programme, currently including International Summer Schools, EC Brokerage Events, Site Visits, and the eseia Conferences, has been

enlarged. Beside the establishment of two new European Master's programmes by the fall of 2017 and Marie Curie funded staff exchanges, the ETP programme added training activities with alternative learning formats, in particular student camps and lab courses. The seven training activities for the year 2016 are listed on the ETP website.

### SuPREME

#### **Start of the Project**

The SuPREME Project (H2020-TWINN-2015) officially started on the 1st of November 2015. The project received 1 Mio. € from the EC Horizon 2020 and is coordinated by the eseia polish member IMP PAN. The objective is twinning for knowledge transfer in integrating energy technologies to create a long lasting and effective partnership that will have a very significant impact on Poland's energy systems infrastructure. A first meeting was held on the 12th of November, and the official Kick-off Meeting will take place on 11-12 January 2015, in Jabłonna, Poland.

#### Report on the ener2i Project

The third ener2i EU International Brokerage event organised by eseia was held on the 2<sup>nd</sup> of December in Brussels. The event gathered together 30 participants from 11 countries, including 2 EaP countries: Armenia and Moldova.

### Smart Cities follow up

An Info Day on Smart Cities & Communities was held on 6 November 2015 in Brussels. The event targeted potential applicants to the Smart Cities & Communities topic of the 2016-2017 Horizon 2020 Work programme 'Cross-cutting activities', Smart and Sustainable Cities Call. Presentations covered the call content and the application procedure. All presentations are available on the event <u>website</u>, as well as a <u>video</u> of the event.



### **Commission Unveils Key Energy Infrastructure Projects**

The European Commission adopts a list of 195 key energy infrastructure projects - known as Projects of Common Interest (PCIs) – which will help deliver Europe's energy and climate objectives and form key building blocks of the EU's Energy Union. The projects will enable the gradual build-up of the Energy Union by integrating the energy markets in Europe, by diversifying the energy sources and transport routes. In addition, the PCI's adopted today will help bring an end to the energy isolation of some Member States. They will also boost the level of renewables on the grid, bringing down carbon emissions. The list includes 108 electricity, 77 gas, 7 oil and 3 smart grids projects. <u>Read more.</u>

### Historic Climate Deal in Paris: EU Leads Global Efforts

The European Union has played a key role in brokering today's historic agreement in Paris, where 195 countries adopted a new universal, legally binding global climate deal. The ambitious and balanced agreement, the first major multilateral deal of the 21st century, sets out a global action plan to put the world on track to avoid dangerous climate change by limiting global warming to well below 2°C. The Paris Agreement sends a clear signal to investors, businesses, and policymakers that the global transition to clean energy is here to stay and resources have to shift away from polluting fossil fuels. <u>Read more.</u>



#### <sup>r</sup> EU shows leadership ahead of Paris with 23% emissions cut

The European Union is on track towards meeting and overachieving its 2020 target for reducing greenhouse emissions by 20%, according to a report published today by the European Environment Agency (EEA). The "Trends and projections in Europe 2015" report reveals that greenhouse gas
